Having regard to Commission Decision No C(2021) 8432 of 29 November 2021,

Having regard the Decision of the Director General No 1/2022³

Having regard to the budget execution of 7 July 2022,

Whereas:

- (1) It is opportune that the Agency is represented at the meetings devoted to the nuclear supply, radiotherapy and nuclear medicine.
- (2) The Agency is committed to implementing the principle of sound financial management.
